SPECIFICATIONS:

- 1) Must be 13A qualified.
- 2) Position requires a secret security clearance.
- 3) Persons receiving or eligible to receive a Federal military retired pay are not eligible.
- 4) Individuals on Temporary Profile or pending MR2 Actions will not be considered for FTNGDOS duty.
- 5) Soldiers with incomplete / outstanding LOD actions or on INCAP pay will not be considered for FTNGDOS duty.
- 6) All applicants must have a current passing APFT and must meet height/weight standards.
- 7) Permanent Change of Station is not authorized.
- 8) Must meet the requirements under Chapter 3, AR 40-501, Standard of Medical Fitness and cannot have a physical profile that prevents them from wearing the full combat uniform, including body armor and helmet.
- 9) Must have a current valid driver's license.
- 10) Soldiers must have less than 15 year's active federal service to apply.
- 11) Orders are subject to the availability of funds and continuation of mission requirements.
